The First Refusal and Fighting Back



The Refusal

IRCC denied the **family sponsorship** application, citing insufficient evidence of the relationship's genuineness and concerns about documentation.



Legal Response

Fateh Law Corporation immediately reviewed the case, identifying **procedural fairness** issues and building a comprehensive response strategy.



Federal Court Application

We filed for **judicial review**, arguing that IRCC failed to properly consider the evidence and violated the principles of natural justice.

Federal Court Win

We immediately filed a second judicial review, pointing out IRCC's failure to comply with the Court's guidance.

The Federal Court sided with our client again, and IRCC finally approved the **family sponsorship application**.
